CONSTRUCTION MANAGER'S CORNER

Happy July Hampton Village Homeowners and Residents!

As you can tell, construction is in full swing with the ongoing balcony repairs. We are currently finishing up Building 14 and working on Buildings 13 & 12 and hope to start Building 11 around July 9th. We are so appreciative of the patience and support of all the residents thus far, but in Buildings 28, 27, 14, 13, and 12. The construction contractor, CAM Construction and Painting, has done a great job thus far and is starting to find their groove to increase productivity whenever possible. We are also starting to prepare to begin the foundation repairs at Building 41 beginning next month, August. Special thanks goes out to the residents of Buildings 41 and 43 that attended the Town Hall Meeting held on June 18th. Your attendance and feedback thus far has really helped us in planning efforts on the repairs of these two buildings. All homeowners affected by this work have already been contacted. As we go through these summer months, we understand that it is an inconvenience for you to not be able to use your balconies but the sooner we can get the construction completed, the sooner that you will be able to use them for years to come.

One item to note, ALL balconies throughout the community will be touched in one way or another. For units ending in 14 & 15, you all do not have a balcony, so this does not apply to you. Primarily, the major repair work is happening on units ending in 11, 12, and 13. Units ending in 16 are just having their deck system recoated. What would help our construction team is if you see us working on the building adjacent to yours, but we haven't started your building yet, there is a good chance we will begin construction activities sometime in the next week. If you want to get a jump on things and start to clear the stuff off your balconies in the meantime, that would be a big help to us all. Also, if your building does not show up on the schedule that is included in this newsletter, that does not mean that we aren't doing any work on your unit. It simply means that work is not scheduled to start until after the last date on that schedule. We are trying to develop a sequence so that we construction activities will only last approximately two and a half weeks, per Building.
